# Doosan Lucky Draw

You understand that by participating in the lucky draw ("Lucky Draw") you are accepting the terms and conditions ("Terms") and agreeing to be bound by them. This Lucky Draw is organized and administered by Doosan ("Sponsor").

## Eligibility

The Lucky Draw is open to all visitors of Las Vegas Convention Center(LVCC) during the CES 2020 period, which is held during 7th~10th January 2020 who are eighteen (18) years of age or older and age of majority in his/her jurisdiction of residence. Employees (including their friends and family members) and subsidiaries of Doosan and the MLB Entities are not eligible to participate in the Lucky Draw. Doosan reserves the right, at its sole discretion, to disqualify your entry if it concludes that: a) you have already won a first prize of the Lucky Draw, or, b) you have acted in violation of the Terms or any applicable state, federal, or local laws or regulations. The decision of Doosan shall be final and binding in all respects and you agree to be bound by the same. The "MLB Entities" shall mean the Office of the Commissioner of Baseball ("BOC"), its Bureaus, Committees, Subcommittees and Councils, MLB Advanced Media, L.P. ("MLBAM"), Major League Baseball Properties, Inc., The MLB Network, LLC, the Major League Baseball Clubs ("Clubs"), each of their parent, subsidiary, affiliated and related entities, any entity which, now or in the future, controls, is controlled by, or is under common control with the Clubs or the BOC and the owners, general and limited partners, shareholders, directors, officers, employees and agents of the foregoing entities.

# **Entry**

By receiving the Lucky Draw ticket at Doosan booth #25318 at CES 2020, you will receive an entry in the Lucky Draw. The entry is free. Tickets will be distributed ninety minutes prior to the event each day at the Information desk located at the west corner of Doosan booth #25318. For each day, the exact time of the Lucky Draw event will be posted around Doosan booth as well as at the Information desk during the exhibition hour. Tickets are also distributed five minutes prior to the event at Doosan booth by on-site Doosan staff members. There is no cost required to receive a ticket.

#### Winner Selection and Notification

Total four (4) prizes will be awarded. A random drawing will take place on each of the 7th, 8th, and 9th January 2020 at the Doosan booth #25318 at CES 2020 to select

one (1) first prize winner and three (3) second prize winners from among all entries received on such day. Non-winning entries from one drawing will not roll over for inclusion in the subsequent drawing, if any. To be eligible to claim any of the prizes, winners must be present at the Doosan booth at the time of the prize drawing. Failure to be present at the drawing will result in the prize being forfeited by the prize winner. In such an event, Doosan reserves the right to award the prize to an alternative winner.

Seat locations at the game and, unless otherwise stated in the prize description, exact game/event/exhibition date shall be determined in the sole discretion of Sponsor. Winner's guest(s) must be of legal age of majority in his/her(their) jurisdiction(s) of residence (and at least eighteen (18) years of age), unless accompanied by a parent or legal guardian. Major League Baseball game, event and exhibition dates and times are determined in the sole discretion of the BOC and/or the applicable Club, as applicable, and may be subject to change. The terms and conditions of the tickets awarded as part of the Prize will govern in the event a legal game, event or exhibition, as defined by Major League Baseball, is not played or held, as applicable, due to weather conditions, an act of God, an act of terrorism, civil disturbance or any other reason. Winner and his/her guest(s) agree to comply with all applicable ballpark and venue, as applicable, regulations in connection with the prize. Sponsor and the applicable MLB Entities reserve the right to remove or to deny entry to the winner and/or his/her guest(s) who engage(s) in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at the game, event or exhibition. Entities will not be responsible for weather conditions, Acts of God, acts of terrorism, civil disturbances, work stoppage or any other natural disaster outside their control that may cause the cancellation or postponement of any Major League Baseball game, event or exhibition. Major League Baseball game, event and exhibition tickets awarded as prizes may not be resold or offered for resale or used for any commercial or promotional purposes whatsoever. Any such resale or commercial or promotional use may result in disqualification and prize forfeiture, and may invalidate the license granted by the game, event or exhibition ticket(s).

The second prize will be comprised of a scale model from Doosan companies (i.e., Doosan Infracore, Doosan Bobcat), as determined by Sponsor. ARV of each second prize is USD 10.

Total ARV of all prizes is USD 630.

Unless expressly stated within these Terms, all other expenses incidental to the

enjoyment of any prize is the responsibility of the winner. For the avoidance of doubt, the prizes exclude any costs for transport, travel, accommodation, spending money, meals, travel documentation and insurance. Winner agrees to comply with any third party terms and conditions in connection with the winner's enjoyment of the prize. The prizes are not transferable, assignable or refundable and cannot be substituted for cash. Prize must be accepted as awarded. Doosan reserves the right to offer an alternate prize of equal or greater value if for any reason any prize cannot be awarded as contemplated by Doosan.
